Opinion

- 2) The compensation amount is calculated in accordance with the requirements of *The Public Sector Compensation Disclosure Act* and includes all payments for regular salary, overtime, acting pay, statutory holiday pay, retirement/severance payments, lump-sum payments, vacation pay-outs, professional dues, allowances with respect to vehicles, any subsidy with respect to living accommodations, and the value of the taxable benefit derived from vehicles, loans and group insurance.
- 3) The Public Sector Compensation Disclosure Act requires public sector bodies to disclose:
- * Compensation paid to the chairperson of the Board of Directors if the chairperson's compensation totals \$85,000 (indexed) or more;
- * The aggregate of compensation paid to the members of the Board of Directors; and
- * Compensation paid to each of the officers and employees whose compensation is \$85,000 (indexed) or more.
